





Ashkelon Acadaemic College through its International Relations Office, in cooperation with international partners, is holding a two-session webinar on the topic:

Youths at-Risk, Minorities, and Gender February 1st, 2022 | 12:00–14:45 (Israel time)

In the globalized world, following extensive migration processes, communities are forming consisting of a variety of ethnic, religious and immigrant groups with different cultures and values. In these multicultural societies, youths from various ethnic minority backgrounds (immigrants, religious or traditional groups) are struggling with the question of how to integrate and be part of a Western society, and to cope with other challenges during their process of acculturation. Identifying the needs and difficulties they face, along with developing appropriate responses for them – is of great importance. This webinar focuses on the risk and resilience factors among youths in minority groups and the development of services addressing their unique challenges and needs, based on two main approaches – the Ecological model and the Risk-Need-Responsivity model (RNR).

The ecological approach to acculturation proposes that minority youths are shaped by their surrounding context and suggests that the ethnic community's culture and values, and the family microsystem play important roles. Specifically, community and parents' acculturation, practices, attitudes, and background have been identified as key factors. This approach also recognizes the unique difficulties for girls, due to the intersectional challenges facing ethnic groups, minorities, and young women.

The Risk-Need-Responsivity model (RNR) has developed as a data-based approach to rehabilitation in the criminal justice system, aimed at reducing the recidivism of offenders. This scientific approach and its recommended practice advance the discourse of "what works" and "what works best" i.e., a best practice. The purpose of this webinar is to present the theoretical and practical framework of the RNR model and its implementation in the field of youth at-risk. The common challenge in the international area requires joint thinking and cooperative discussion which the workshop provides. The webinar poses an opportunity to gain new insights on this issue for practitioners and researchers.
