







Ashkelon Academic College, through its International Relations Office, in cooperation with the Free University Berlin and international partners, is holding a three-session webinar for scholars, policy makers, and practitioners on the topic:

Fathers and the Family Welfare and Child Protection Services: Theory, Research, and Practice

February 24th, 2022 | 13:00-17:30

(Central European Time; 14:00-18:30 Israel Time)

Fathers are under-represented in family and child-oriented interventions of the family welfare and child protection services and in research on those services. In practice, data from various countries and welfare systems shows that interventions in Western countries incorporate mothers primarily, while fathers are often left out; within academia, research tends to focus on the relationships of social workers with mothers, neglecting the role of fathers.

However, several strands of research on fathers' interaction with family welfare and child protection services have begun emerging in recent years, focusing on the roots of this under-representation and the roles of fathers, workers, and other elements in it.

This webinar aims to bring together these different research approaches and learn from scholars (and practitioners) from various countries. The webinar will focus, first, on examining the theoretical questions arising from the interactions of fathers and the welfare system, while considering different welfare regimes and diverse types of family welfare services. The webinar will also examine the state of current research on the issue, what we know, and what has yet to be studied; last, the webinar will ask how these findings can improve services given to fathers, children, and families. Another aim is to create a fruitful discourse among the academic world, field practitioners, and policymakers in different countries, and facilitate future corporations.
